Beverly Panthers Code of Ethics

I hereby agree that if I fail to conform my conduct to the foregoing while attending, coaching, or participating in a youth sports event I will be subject to disciplinary action, including but not limited to the following in any order or combination:

- 1. Verbal warning issued by the league, organization
- 2. Written warning issued by the league, organization
- 3. Suspension or immediate ejection from a youth sports event issued by a league, organization or any official who is authorized to issue such suspension or ejection by the board or youth sports organization.
